



Step 1 **Duplicate Order Check**

Determination is made whether the carrier has ordered the MVR previously, if yes, and certain conditions are satisfied, then a copy is provided for a nominal charge.




Step 2 **Driver Activity Files**

The driver is checked against the activity files - if no violations can be found in the activity files, then a "clear" is reported back at a reduced cost as compared to the cost of an MVR. About 70% of all drivers have no MVR violations.
